We need to urgently verify the status of these staff and either furlough or terminate them as required, unless they are active, meant to be active, and there are good reasons for them not having received a paycheck (i.e., new hires, etc.).

Kindly reach out to all stations concerned and report back on the status of all highlighted employees. CARES is now imminent, and we need to ensure we don't incur unnecessary costs once the ink is on the paper.
